*H-195 Proposed by Verner E. Hoggatt, Jr., San Jose State College, San Jose, California*

Consider the array indicated below:

- (i) Show that the row sums are  $F_{2n}$ ,  $n \geq 2$ .
- (ii) Show that the rising diagonal sums are the convolution of

$$\{F_{2n-1}\}_{n=0}^{\infty} \quad \text{and} \quad \{u(n; 2, 2)\}_{n=0}^{\infty},$$

the generalized numbers of Harris and Styles.

*H-196 Proposed by J. B. Roberts, Reed College, Portland, Oregon.*

- (a) Let  $A_0$  be the set of integral parts of the positive integral multiples of  $\tau$ , where

$$\tau = \frac{1 + \sqrt{5}}{2},$$

and let  $A_{m+1}$ ,  $m = 0, 1, 2, \dots$ , be the set of integral parts of the numbers  $n\tau^2$  for  $n \in A_m$ . Prove that the collection of  $Z^+$  of all positive integers is the disjoint union of the  $A_j$ .

(b) Generalize the proposition in (a).

*H-197 Proposed by Lawrence Somer, University of Illinois, Urbana, Illinois.*

Let  $\{u_n^{(t)}\}_{n=1}^{\infty}$  be the  $t$ -Fibonacci sequences with positive entries satisfying the recursion relationship:

$$u_n^{(t)} = \sum_{i=1}^t u_{n-i}.$$

Find

$$\lim_{n \rightarrow \infty} \frac{u_{n+1}^{(t)}}{u_n^{(t)}}.$$

#### SOLUTIONS

#### HYPER-TENSION

*H-185 Proposed by L. Carlitz, Duke University, Durham, North Carolina.*

Show that

$$(1 - 2x)^n = \sum_{k=0}^n (-1)^{n-k} \binom{n+k}{2k} \binom{2k}{k} (1-v)^{n-k} {}_2F_1[-k; n+k+1; k+1; x],$$

where  ${}_2F_1[a, b; c; x]$  denotes the hypergeometric function.

*Solution by the Proposer.*

We start with the identity

$$\sum_{r,s=0}^{\infty} \frac{(2r+3s)!}{r!s!(r+2s)!} \frac{(y-z)^r z^s}{(1+y)^{2r+3s+1}} = \frac{1}{1-y-z}.$$

Now put  $y = u + v$ ,  $z = v$ , so that

$$(*) \quad \sum_{r,s=0}^{\infty} \frac{(2r+3s)!}{r!s!(r+2s)!} \frac{u^r v^s}{(1+u+v)^{2r+3s+1}} = \frac{1}{1-u-2v}.$$

The right-hand side of (\*) is equal to

$$\sum_{n=0}^{\infty} (u + 2v)^n ,$$

while the left-hand side

$$= \sum_{r,s=0}^{\infty} \frac{(2r+3s)!}{r!s!(r+2s)!} u^r v^s \sum_{k=0}^{\infty} (-1)^k \binom{2r+3s+k}{k} (u+v)^k .$$

It follows that

$$\begin{aligned} (u+2v)^n &= \sum_{k=0}^n (u+v)^k \sum_{r+s=n-k} (-1)^k \binom{2r+3s+k}{k} \frac{(2r+3s)!}{r!s!(r+2s)!} u^r v^s \\ &= \sum_{r+s \leq n} (-1)^{n-r-s} \frac{(r+2s+n)!}{r!s!(r+2s)!(n-r-s)!} u^r v^s (u+v)^{n-r-s} \\ &= \sum_{k=0}^n (-1)^{n-k} \frac{(u+v)^{n-k}}{(n-k)!} \sum_{s=0}^k \frac{(s+n+k)!}{s!(k-s)!(k+s)!} u^{k-s} v^s . \end{aligned}$$

Taking  $u = 1$ ,  $v = -x$ , we get

$$(1-2x)^n = \sum_{k=0}^n (-1)^{n-k} \frac{(n+k)!}{k!k!(n-k)!} (1-v)^{n-k} {}_2F_1[-k, n+k+1; k+1; x] .$$

#### A CONGRUENCE IN ITS PRIME

*H-186 Proposed by James Desmond, Florida State University, Tallahassee, Florida.*

The generalized Fibonacci sequence is defined by the recurrence relation

$$U_{n-1} + U_n = U_{n+1} ,$$

where  $n$  is an integer and  $U_0$  and  $U_1$  are arbitrary fixed integers.

For a prime  $p$  and integers  $n$ ,  $r$ ,  $s$  and  $t$ , show that

$$U_{np+r} \equiv U_{sp+t} \pmod{p} ,$$

if  $p \equiv \pm 1 \pmod{5}$  and  $n + r = s + t$ , and that

$$U_{np+r} \equiv (-1)^{r+t} U_{sp+t} \pmod{p}$$

if  $p \equiv \pm 2 \pmod{5}$  and  $n - r = s - t$ .

*Solution by the Proposer.*

We have from Hoggatt and Ruggles, "A Primer for the Fibonacci Sequence — Part III," Fibonacci Quarterly, Vol. 1, No. 3, 1963, p. 65, and by Fermat's theorem, that

$$F_{np+r} = \sum_{i=0}^p \binom{p}{i} F_{i+r} F_n^i F_{n-1}^{p-i} \equiv F_r F_{n-1}^p + F_{p+r} F_n^p \equiv F_r F_{n-1} + F_{p+r} F_n \pmod{p}$$

for all  $n$  and  $r$ . From I. D. Ruggles, "Some Fibonacci Results Using Fibonacci-Type Sequences," Fibonacci Quarterly, Vol. 1, No. 2, 1963, p. 79, we have that

$$F_{i+j} = F_{i+1} F_j + F_i F_{j-1}$$

for all  $i$  and  $j$ . Therefore,

$$F_{np+r} \equiv F_r F_{n-1} + F_{r+1} F_p F_n + F_r F_{p-1} F_n \pmod{p}$$

for all  $n$  and  $r$ . We have from Hardy and Wright, Theory of Numbers, Oxford University Press, London, 1954, p. 150, that

$$F_{p-1} \equiv 0 \pmod{p} \quad \text{and} \quad F_p \equiv 1 \pmod{p}$$

if  $p \equiv \pm 1 \pmod{5}$ , and that

$$F_{p+1} \equiv 0 \pmod{p} \quad \text{and} \quad F_p \equiv 1 \pmod{p}$$

if  $p \equiv \pm 2 \pmod{5}$ . Let  $p \equiv \pm 1 \pmod{5}$  and  $n + r = s + t$ . Then

$$F_{np+r} \equiv F_r F_{n-1} + F_{r+1} F_n \equiv F_{r+n} \pmod{p}$$

for all  $n$  and  $r$ . Therefore

$$F_{sp+t} \equiv F_{s+t} \equiv F_{n+r} \equiv F_{np+r} \pmod{p}.$$

It is easily verified by induction that

$$U_n = U_1 F_n + U_0 F_{n-1}$$

for all  $n$ . Therefore

$$U_{np+r} \equiv U_1 F_{np+r} + U_0 F_{np+r-1} \equiv U_1 F_{sp+t} + U_0 F_{sp+t-1} \equiv U_{sp+t} \pmod{p}.$$

Now, let  $p \equiv +2 \pmod{5}$  and  $n - r = s - t$ . From page 77 of the reference to Ruggles, we have

$$F_{i+j} - F_i L_j = (-1)^{j+1} F_{i-j}$$

for all  $i$  and  $j$ . Therefore

$$\begin{aligned} F_{np+r} &\equiv F_r F_{n-1} - F_{r+1} F_n + F_r F_n \equiv F_r F_{n-1} + F_{r+1} F_n - 2F_{r+1} F_n + F_r F_n \\ &\equiv F_{r+n} - L_r F_n \equiv (-1)^{r+1} F_{n-r} \pmod{p} \end{aligned}$$

for all  $n$  and  $r$ . Thus

$$(-1)^{r+t} F_{sp+t} \equiv (-1)^{r+t} (-1)^{t+1} F_{s-t} \equiv (-1)^{r+1} F_{n-r} \equiv F_{np+r} \pmod{p}.$$

Hence

$$\begin{aligned} U_{np+r} &\equiv U_1 F_{np+r} + U_0 F_{np+r-1} \equiv U_1 (-1)^{r+t} F_{sp+t} + U_0 (-1)^{r-1+t-1} F_{sp+t-1} \\ &\equiv (-1)^{r+t} (U_1 F_{sp+t} + U_0 F_{sp+t-1}) \equiv (-1)^{r+t} U_{sp+t} \pmod{p}. \end{aligned}$$

#### FIBONACCI IS A SQUARE

*H-187 Proposed by Ira Gessel, Harvard University, Cambridge, Massachusetts.*

Problem: Show that a positive integer  $n$  is a Fibonacci number if and only if either  $5n^2 + 4$  or  $5n^2 - 4$  is a square.

*Solution by the Proposer.*

Let  $F_0 = 0$ ,  $F_1 = 1$ ,  $F_{r+1} = F_r + F_{r-1}$  be the Fibonacci series and  $L_0 = 2$ ,  $L_1 = 1$ ,  $L_{r+1} = L_r + L_{r-1}$  be the Lucas series. It is well known that

$$(1) \quad (-1)^r + F_r^2 = F_{r+1} F_{r-1}$$

$$(2) \quad L_r = F_{r+1} + F_{r-1}.$$

Subtracting four times the first from the square of the second equation, we have

$$L_r^2 - 4(-1)^r - 4F_r^2 = (F_{r+1} - F_{r-1})^2 = F_r^2,$$

whence

$$5F_r^2 + 4(-1)^r = L_r^2.$$

Thus if  $n$  is a Fibonacci number, either  $5n^2 + 4$  or  $5n^2 - 4$  is a square.

I have two proofs of the converse.

First Proof. We use the theorem (Hardy and Wright, An Introduction to the Theory of Numbers, p. 153) that if  $p$  and  $q$  are integers,  $x$  is a real number, and  $|(p/q) - x| < 1/2q^2$ , then  $p/q$  is a convergent to the continued fraction for  $x$ , and that (Hardy and Wright, p. 148) the convergents to the continued fraction for  $(1 + \sqrt{5})/2$  in lowest terms are  $F_{r+1}/F_r$ .

Assume that  $5n^2 \pm 4 = m^2$ . Then since  $m$  and  $n$  have the same parity,  $k = (m + n)/2$  is an integer. Then substituting  $m = 2k - n$  in  $5n^2 \pm 4 = m^2$ , we get  $k^2 - kn - n^2 = \pm 1$ , so that  $k$  and  $n$  are relatively prime and

$$\pm 1/n^2 = (k/n)^2 - (k/n) - 1 = [(k/n) - (\sqrt{5} + 1)/2] [(k/n) + (\sqrt{5} - 1)/2].$$

Thus

$$|(k/n) - (\sqrt{5} + 1)/2| = 1/n^2 |(k/n) + (\sqrt{5} - 1)/2|.$$

Since 1 is a Fibonacci number, we may assume  $n \geq 2$ . Then

$$(2k - n)^2 = m^2 \geq 5n^2 - 4 = 4n^2 + (n^2 - 4) \geq 4n^2,$$

so  $2k - n \geq 2n$ , whence  $k/n \geq 3/2$ . Thus  $(k/n) + (\sqrt{5} - 1)/2 > 2$ , so by the two theorems quoted above,  $k/n = F_{r+1}/F_r$  for some  $r$ , and since both fractions are reduced,  $n = F_r$ .

Second Proof. Assume  $5n^2 \pm 4 = m^2$ . Then  $m^2 - 5n^2 = \pm 4$ , so

$$\frac{m + \sqrt{5}n}{2} \cdot \frac{m - \sqrt{5}n}{2} = \pm 1,$$

and since  $m$  and  $n$  have the same parity,

$$\frac{m + \sqrt{5}n}{2} \quad \text{and} \quad \frac{m - \sqrt{5}n}{2}$$

are integers in  $Q(\sqrt{5})$ , where  $Q$  is the rationals, and since their product is  $\pm 1$ , they are units. It is well known (Hardy and Wright, p. 221) that the only integral units of  $Q(\sqrt{5})$  are of the form  $\pm x^{\pm r}$ , where  $x = (1 + \sqrt{5})/2$ .

Then we have

$$(m + \sqrt{5}n)/2 = x^r = \frac{1}{2} \left[ (x^r + y^r) + \frac{x^r - y^r}{\sqrt{5}} \cdot \sqrt{5} \right],$$

where  $y = -1/x$ . Now  $x^r + y^r = L_r$  and

$$(x^r - y^r)/\sqrt{5} = F_r$$

(Hardy and Wright, p. 148). Thus

$$\frac{1}{2}(m + \sqrt{5}n) = \frac{1}{2}(L_r + \sqrt{5}F_r),$$

so  $n = F_r$ .

#### SUM SERIES

H-189 Proposed by L. Carlitz, Duke University, Durham, North Carolina (Corrected).

Show that

$$\sum_{r,s=0}^{\infty} \frac{(2r+3s)!}{r!s!(r+2s)!} \frac{(a-by)^r b^s y^{r+2s}}{(1+ay)^{2r+3s+1}} = \frac{1}{1-ay-by^2}$$

*Solution by the Proposer.*

Put

$$\frac{1}{1-ax-bx^2} = \sum_{m=0}^{\infty} G_m x^m,$$

so that

$$\frac{1}{(1-ax-bx^2)(1-y)} = \sum_{m,n=0}^{\infty} G_m x^m y^n.$$

Replacing  $y$  by  $x^{-1}y$  this becomes

$$\frac{1}{(1-ax-bx^2)(1-x^{-1}y)} = \sum_{m,n=0}^{\infty} G_m x^{m-n} y^n.$$

Hence that part of the expansion of

$$\frac{1}{(1-ax-bx^2)(1-x^{-1}y)}$$

that is independent of  $x$  is equal to

$$(*) \quad \frac{1}{1 - ay - by^2}$$

On the other hand, since

$$(1 - ax - bx^2)(1 - x^{-1}y) = (1 + ay) - x(a - by) - bx^2 - x^{-1}y,$$

we have

$$\begin{aligned} (1 - ax - bx^2)^{-1}(1 - x^{-1}y)^{-1} &= \sum_{k=0}^{\infty} \frac{[x(a - by) + bx^2 + x^{-1}y]^k}{(1 + ay)^{k+1}} \\ &= \sum_{r, s, t=0}^{\infty} \frac{(r + s + t)!}{r!s!t!} \frac{(a - by)^r b^s y^t}{(1 + ay)^{r+s+t+1}} x^{r+2s-t}. \end{aligned}$$

The part of this sum that is independent of  $x$  is obtained by taking  $t = r + 2s$ . We get

$$\sum_{r, s=0}^{\infty} \frac{(2r + 3s)!}{r!s!(r + 2s)!} \frac{(a - by)^r b^s y^{r+2s}}{(1 + ay)^{2r+3s+1}}.$$

Since this is equal to (\*), we have proved the stated identity.

#### IT'S A MOD WORLD

*H-190 Proposed by H. H. Ferns, Victoria, British Columbia.*

Prove the following

$$\begin{aligned} 2^r F_n &\equiv n \pmod{5} \\ 2^r L_n &\equiv 1 \pmod{5}, \end{aligned}$$

where  $F_n$  and  $L_n$  are the  $n^{\text{th}}$  Fibonacci and  $n^{\text{th}}$  Lucas numbers, respectively, and  $r$  is the least residue of  $n - 1 \pmod{4}$ .

*Solution by the Proposer.*

In an unpublished paper by the proposer, it is shown that

$$2^{n-1} F_n = \sum_{k=0}^{\left\lfloor \frac{n-1}{2} \right\rfloor} \binom{n}{2k+1} 5^k.$$



Hence

$$2^{n-1}F_n = n + \sum_{k=1}^{\left[\frac{n-1}{2}\right]} \binom{n}{2k+1} 5^k.$$

Thus

$$2^{n-1}F_n \equiv n \pmod{5}.$$

Let  $n-1 = 4m+r$ , where  $0 \leq r < 4$ . Then

$$2^{n-1}F_n = 2^{4m+r}F_n = 2^{4m}2^rF_n \equiv n \pmod{5}.$$

But

$$2^{4m} = (2^4)^m \equiv 1 \pmod{5}.$$

Hence

$$2^rF_n \equiv n \pmod{5}.$$

To prove

$$2^rL_n \equiv 1 \pmod{5},$$

use

$$2^{n-1}L_n = \sum_{k=0}^{\left[\frac{n}{2}\right]} \binom{n}{2k} 5^k$$

(which is derived in the same paper) and proceed as above.

#### JUST SO MANY TWO'S

*H-192 Proposed by Ronald Alter, University of Kentucky, Lexington, Kentucky.*

If

$$c_n = \sum_{j=0}^{3n+1} \binom{6n+3}{2j+1} (-11)^j,$$

prove that

$$c_n = 2^{6n+3} \cdot N, \quad (N \text{ odd, } n \geq 0).$$

*Solution by the Proposer.*

In the sequence

$$b_k = b_{k-1} - 3b_{k-2}, \quad (k \geq 1, \quad b_1 = b_2 = 1),$$

it is easy to show that 2 is the highest power of 2 that divides  $b_k$  if and only if  $k \equiv 3 \pmod{6}$ . Also, by deriving the appropriate Binet formula, it follows that

$$b_k = \frac{1}{\sqrt{-11}} \left\{ \left( \frac{1 + \sqrt{-11}}{2} \right)^k - \left( \frac{1 - \sqrt{-11}}{2} \right)^k \right\}, \quad k \geq 1.$$

Thus

$$b_k = \frac{1}{2^{k-1}} \sum_{j=0}^{\lfloor \frac{k-1}{2} \rfloor} \binom{k}{2j+1} (-11)^j, \quad k \geq 1.$$

The desired result follows by observing

$$b_{6n+3} = \frac{1}{2^{6n+2}} c_n.$$

## A GOLDEN SECTION SEARCH PROBLEM

After tiring of using numerous quadratic functions as objective functions for examples in my mathematical programming course, I posed the following problem for myself: Design a unimodal function over the (0,1) interval which is concave, has a maximum in the interior of (0,1), and is not a quadratic function. The purpose was to demonstrate numerically the golden section search.\*

My first thoughts were to add two functions which are concave over the (0,1) interval with the property that one goes to  $-\infty$  at 0 and the other goes to  $-\infty$  at 1. My two initial choices were  $\log x$  and  $1/(x-1)$ . The golden section search starts at the two points  $x_1 = 1 - (1/\phi)$  and  $x_2 = 1/\phi$  where  $\phi = (1 + \sqrt{5})/2$ . After searching with 8 points, I noticed that the interval of uncertainty still contained the first search point so I thought it about time to find the location of the maximum analytically. I was dumfounded to discover that if I continued indefinitely with the search my interval of uncertainty would still contain the initial search point.
